



NEW PUMP EFFICIENCY UPGRADE PROGRAM REBATE APPLICATION

To be eligible for a reimbursement, the pump must replace an old inefficient pump with a new pump (not a rebuilt or used pump).

1. Send a copy of the VFD proposal from your contractor and this application, to CPI Irrigation Program, P.O. Box 1180, Philomath, OR 97370 (email: info@cpi.coop)
2. DO NOT BEGIN WORK UNTIL YOU HAVE RECEIVED PREAPPROVAL FROM CPI.
3. Once the application and proposal have been reviewed and approved, the application will be signed by a CPI representative and returned to you. You will schedule with your contractor when work will begin.
4. Your contractor will notify CPI when the work is complete. Once the job has been verified as correct and complete, CPI will send the rebate to the applicant listed below.
