The system must have a minimum HSPF of 9 and a SEER of 14.</i> \$500 for qualifying heat pump</p> <p><i>For converting an existing forced air furnace to an air source heat pump. The system must have a minimum HSPF of 9 and a SEER of 14.</i> \$1,500 for qualifying heat pump</p> <p>Commissioning and Controls for any heat pump in new or existing homes. \$300 for any new heat pump meeting Federal minimum standards</p> |
| | <p>Ductless Heat Pump (New or Existing Homes) The system must have a minimum HSPF of 9 for existing and 10 for new homes. \$900 per residence with zonal electric heat or electric furnace. \$500 for new homes and must install a heat pump water heater. (Cannot claim both.)</p> |
| Other | <p>New Energy Star Clothes Washer and Dryer (New or Existing Homes) \$30 for clothes washer, must have electric water heating and be Energy Star certified. \$50 for clothes dryer, must be Energy Star certified.</p> |
| | <p>Smart Power Strips (New or Existing Homes) Come visit our office and pick up ONE free Smart Power Strip.</p> |
| | <p>Energy Star Electric Vehicle Charger \$50 for an Energy Star, Connected Functionality Capable electric vehicle charger.</p> |
| | <p>Smart Thermostats (New or Existing Homes) \$100 for installing a new smart thermostat. Please see website for qualified products. Max two units per home and must control either an electric furnace or heat pump system and must not have gas in the home.</p> |
